



## 2021 ASHA Audiology and Speech-Language Pathology Assistants Survey Results

### Survey Methodology and Response Rate

The ASHA Surveys and Analysis team sent a web survey to 449 individuals who were on an ASHA email list for assistants on September 14, 2021. Follow-up email reminders were sent to non-respondents on September 21 and 28. The survey closed on October 8. The number of respondents was 183—a 40.8% response rate.

A random sample of 14,641 supervisors of assistants was also asked to pass along the survey invitation to their assistants on September 15 and a survey link was posted on specific ASHA social media sites as well. An additional 169 responses were received through the supervisors' email and 672 through social media, for an overall total of 1,024 respondents. All participants had the opportunity to enter a drawing for a \$100 Amazon.com gift card.

### Survey Results

Responses are presented separately for Audiology Assistants (“AA”) and Speech-Language Pathology Assistants (“SLPA”), and for other groups of respondents whenever possible. Percentages are rounded and may not add to exactly 100%. Data are not presented for table cells with fewer than 25 respondents. Cells with a “—” indicate that the response option was not available for the group. Comments have been lightly edited for grammar and spelling.
